



**APPLICATION FOR LICENSE AS A  
CEMETERY SALES ORGANIZATION  
CEMETERY MANAGEMENT ORGANIZATION  
INSTRUCTIONS**

---

1. Application must be completed in full and executed by each owner, partner, stockholder, and/or member, owning 10% or more, or a majority of the officers, directors, and/or LLC managers of the Applicant, if publicly-traded.
2. Individual's Questionnaire must be completed in full by each owner, partner, stockholder, and/or member, owning 10% or more, officer, director, LLC manager, general manager, etc., of the Applicant. A current credit report from a credit bureau must accompany each Individual's Questionnaire. NOTE: If Applicant is owned or LLC managed by a corporation or limited liability company, a Corporate/LLC Questionnaire must be submitted.
3. Application fee in the amount of two hundred fifty dollars (\$250.00). If ninety percent (90%) or more of the Applicant is owned by an existing Cemetery Authority operating under Title 8, then the initial filing fee shall be one-half or one hundred twenty-five dollars (\$125.00). Please make check or money order payable to the Louisiana Cemetery Board.
4. The following documents must accompany the Application for License as a Cemetery Sales or Management Organization:
  - a) CERTIFIED copy of Articles of Incorporation, Charter, or Articles of Organization.
  - b) If a foreign corporation or limited liability company, evidence of qualification to do business in Louisiana.
  - c) By-laws or Operating Agreement, if they exist.
  - d) The address of each of the Applicant's offices within and without the state.
  - e) Three (3) years financial statements. If a new corporation or limited liability company, submit a statement estimating receipts (including capitalization, sales, loans, etc.) and expenditures for the next two (2) years.
  - f) A narrative description of the promotional plan for the sale of cemetery property and services, as well as, copies of all contracts, agreements, and advertising material to be used in the promotional plan.
  - g) Executed copy of all contract(s) between Applicant and any Cemetery Authority located in Louisiana.

If assets, stock or membership interest of Applicant has been purchased, the following will also be required:

  - h) Purchase agreement.
5. There shall be submitted to the Board such additional information and/or documentation the Board may deem necessary.
